# Post office will be privatized from 1<sup>st</sup> October.

# •••But please do not worry. There are no changes in usage of postal service.

Japan Postal Service Public Corporation is the official name of post office till today. From 1<sup>st</sup> October, it will be privatized and divided into three, Postal Service Co., Ltd, Postal Savings Co., Ltd, and Postal life Insurance Co., Ltd. There works are handled by "window outsourcing". The post office involving this work is "Postal Service Co., Ltd". We picked up some main points from general guidance of post office.

# Q How is the post office going to be?

As so far, you will be offered postal service, saving service and insurance service in any post office.

# Q Can we still use the old stamps and postcards?

Yes, there is no problem to use those stamps and postcards issued before privatization.

Q What should I do when I post?

Please go to post office or use postbox as before.

# Q Is delivery service the same as before?

Yes, there is no change on it. In the same principle as before, postal matters will be delivered within 3 days counted from the next day you post. It is also applied to parcel delivery.

# Q Will postal charges be changed?

- Postal services and parcel delivery will keep the same price. Letter and postcard are at the flat rate domestically.
- Q How should I receive postal deliveries?

In the case when you miss to receive delivery, as usual, it will be re-delivered at your available time. Otherwise in advice you can request to receive it in "Yu-Yu window of Postal Service Co., Ltd or post office which is convenient for you.

- **Q** How can I pay for tax changed on delivery from overseas? Only you have to do is to pay postman for the tax.
- Q Where should I contact for postal inquiry?

# Q Are there any influences on the present postal savings and postal life insurance?

It will be managed succeeding at the post office. Postal savings deposited before privatization are taken over to the Postal Savings Co., Ltd. You can also contact post office for the regular postal savings and contract for postal life insurance.

# ••Do you know EMS service?

In EMS service, letters, business documents and parcels are delivered to over 120 countries. The EMS price starts from \$ 900. It costs \$ 1800 for 1kg to Asia. In counter of post office, you need to fill a form for document or parcel.

# Do you know penalties for drunken drive is now more severe?

From 19<sup>th</sup> September, actions of offering liquor and car which can result in drunken drive and hit-and-run now face reinforcement of penal regulations. The below-stated information is the summary of the new penalty.
